
Sir,

With reference to the subject cited above, I am directed to state that as per the guidelines of the Ministry of Finance, Govt. of India, Utilization Certificates under award of Central Finance Commission grant for the Local Bodies are to be submitted as per **Annexure -III** as given in the guidelines issued on 08/10/2015 by the Ministry of Finance, Govt. of India. However, the office of the Principal Accountant General (A & E), Assam has been insisting Finance Department to submit Utilization Certificates as per **GFR-19-A** format giving countersignature by the Secretary, Finance Department on the Utilization Certificates.

It may be indicated that the State Finance Department issues sanction and release funds to the Local Bodies similar to the system followed by Ministry of Finance while releasing Local Bodies Grants to the States. Concerned Local Bodies are implementing authority and they are responsible for submitting UCs against releases made to them.

In view of above, I would like to request you to kindly give necessary clarifications and guidelines in respect of Local Bodies Grants released by State Government in order that the office of Accountant General is properly enlightened and the confusion in this regard is clarified.


