

Sl. No.	Conditions	Action by the Department
1	Budget, Finance & Accounts	Supplement Budget for local bodies for 2011-12 to be prepared by Finance (Budget) Department. P & RD and U.D. Departments have submitted Certificate that they have implemented National Model Accounting System. But G.D. Department has not yet furnished such certificate.
2	Audit	Finance (Audit & Fund) Department yet to take action on the matter that Annual Inspection Report of C&AG for local bodies and the Annual Report of the Director of Audit (Local Fund) should be placed before the State Legislature. Instructions yet to be issued by the <b>P&amp;RD, UDD, GDD, WPT&amp;BC and HAD</b> to Local Bodies/VCDC & TVC for adoption of existing 8 data base formats prescribed by A.G. and allotment of specific codes to each Local Self Govt. Institutions
3	Ombudsman/Lok Ayukta	P&RD and U D Departments have furnished certificates. But G.D. Department, H.A. Department & WPT & BC Department have not yet furnished certificate.
4	Transfer of Funds to local bodies	Certificate will be given by SFC Cell of Finance (Economic Affairs) Department subject to receipt of information from the concerned DDOs.
5	Act for State Finance Commission	Copy of the Act will be submitted by SFC Cell of Finance (Economic Affairs) Department
6	Levy of Property Tax	P & RD and U D Department have furnished certificates. But G D Department has not yet furnished.
7	Property Tax Board	U D Department has furnished certificate. But GD Department has not yet furnished.
8	Service Delivery Benchmarks	U D Department has furnished certificate. But GD Department has not yet furnished.
9	Disaster Management Plan.	Publication of mitigation plan for respective jurisdiction of Municipal Corporation in the State gazette will demonstrate compliance with this condition. G.D. Department yet to take action.

10	U.C. against 1 <sup>st</sup> instalment of 2010-11 for General Grant & Specific Grant	P & RD, UD, GD, WPT&BC and HA Departments shall submit UCs as per prescribed Formats of GOI.
11	Strengthening of local fund audit department	To earmark an estimated amount of Rs.23.76 crore out of the devolution fund of 13 <sup>th</sup> Finance Commission for strengthening of local fund audit offices under Director of Audit (Local Fund), Assam with the approval of HLC.
