





Certification on compliance of the conditions by Panchayat & Rural Development Department in the Govt. of Assam for availing Performance Grant under Thirteenth Finance Commission.

1. The Model Accounting System (PRIAsoft) developed by MoPR, Gol. has been implemented by the Panchayat & Rural Development Department in the Govt. of Assam in pursuance of Gol's letter No.M-11011/54/2009-P&C(AR) dtd. 2nd October 2009, which has been developed in consultation with C&AG.
2. State LoK Ayukta under the Assam LoK Ayukta and Up-LoK Ayukta Act, 1985 includes the functionaries of local bodies for investigation under the Act into the complaints of corruption and maladministration against these functionaries.
3. As per Section 28, 57 & 95 of the Assam Panchayat Act, 1994, provision has been made to levy Taxes on the houses, Cinema halls, Brick Kilns, Saw mills etc which has been implemented in the PRIs.
