It is for kind information that the Fourteen Finance Commission, which was constituted by Presidential Order dated 2nd January, 2013, have asked for relevant data/figures on 60 Formats from all States vide their letter dated 31/1/2013. We have already called for information/data on those 60 formats from the concerned departments vide our letter dated 16/2/2013.
