**Sub: Questionnaire relating to the Fourth Assam State Finance Commission.**

Sir,

In continuation of letter No FEA(SFC)57/2010/39 dated 20.05.2010, the Fourth Assam State Finance Commission has been constituted by the Government of Assam vide notification No.FEA(SFC)110/209/114 dated 23<sup>rd</sup> April,2010 headed by Shri P.K.Bora, Ex-Chief Secretary, Govt of Assam and four other members.

In terms of the provision of Articles 243 I and 243 Y of the Constitution, the Commission is required to make recommendations as to the following:


- (i) the principles of distribution between the State and the Panchayat and the Municipalities of the net proceeds of taxes and duties levied and collected by the Government of Assam.
- (ii) the determination of the taxes, duties, tolls and fees, which may be assigned to, or appropriated by the Panchayats/Municipalities.
- (iii) the grants-in-aid to the Panchayats/Municipalities from the Consolidated Fund of the State.
- (iv) The measures needed to improve the financial position of the Panchayats/ Municipalities.

In accordance with the terms of reference (ToR) given to the Commission, among other things, it is also required to make a review of the receipts and expenditure of the Local Bodies as a whole and of each local body severally. In order to make an assessment of the financial position of the PRIs and ULBs at all levels, the Commission will require a lot of information and data each local body-wise. The details of such information and data are incorporated in a questionnaire framed separately for the Panchayats and Municipalities.

**A portion of the questionnaire Annexure -I relating to SOURCE OF REVENUE /CAPITAL OF PRIs AND EXPENDITURE** is appended here to with the request to get it circulated to district Assistant Director of Audit (Local Fund) and instruct them to fill the questionnaire in respect of each ZILLA PARISHAD AND ALL THE ANCHALIC PANCHAYAT. The filled in questionnaire sent back to you for consolidation and onward transmission to Government both hard and soft copies.

You are, therefore, requested kindly to ensure that replies to the questionnaire complete in all respect should reach SFC (Cell) of Finance (Economic Affairs) Department **on or before 15<sup>th</sup> June, 2010.**


