ORDER BY THE GOVERNOR

No. FEA (SFC) 25/2013/16

Dated Dispur the April 26, 2013

In pursuance of the Notification No.FEA(SFC).140/2012/80 dated 5<sup>th</sup> March, 2013 regarding constitution of the Fifth Assam State Finance Commission under the chairmanship of Shri M.P. Bezbaruah, IAS (Retd.), following terms and conditions have been fixed against his appointment.

1. Difference of the present pension and salary (except Medical Allowance.) per month only, if had been in service at present deemed to be honorarium shall be paid.
2. Status in the rank of Chief Secretary is accorded to the Chairman of the Commission.
3. Tour within the State without the permission of C.M. may be undertaken by the Chairman as deemed necessary by him.
4. For tour outside the State in connection with SFC related works, the Chairman is to take prior approval of the Chief Minister. TA/DA shall be entitled as admissible in the rank of Chief Secretary.
5. Reimbursement against expenses of entertainment and refreshment upto the limit of Rs.5000/- only per month.
6. Reimbursement against bills of Land Telephone at Residence up to the limit of Rs.5000/- only per month and one Mobile Phone up to the limit of Rs.1000/- only per month.
7. Reimbursement against cost of 3 Nos of Local Newspaper and 5 Nos of National Newspaper is admissible. In addition to that, Books, Periodicals, Magazines etc. worth Rs.900/- (Rupees nine hundred) only per month are also entitled.
8. A car with a driver shall be provided by the S.A. (Estt.) Department.
9. Reimbursement against cost of 60 liters of petrol/diesel per month shall be admissible.
10. Office accommodation for the Chairman and supporting officers and staff for the Chairman shall be provided by the S.A. (Estt.) Department.
11. Allotment of Government Quarter for accommodation in the Senior Officers' Colony at Khanapara, Guwahati will be provided by General Administration Department.

12. Personal staff including stenographers and peons shall be provided by the S.A. (Estt.) Department for the Chairman.
13. Chairman shall be entitled to engage bungalow peon as per procedure and as admissible to the Senior Grade Officer of the State Government.
