
I am directed to say that the Governor of Assam is pleased to accord Administrative Approval for an amount Rs.3.00 crore (Rupees three crore) only for construction of Office Building cum Commercial Complex for **Barpeta, Municipal Board** under the award of Third Assam State Finance Commission during 2010-11:

1. Chairperson of Barpeta ,MB, Assam will maintain separate account for the project as per Assam Financial Rules for execution of the work /project.
2. The competent authority shall issue Technical sanction of the plan and estimate before start of the construction.
3. Tender against the works to be followed by the Board as per existing procedure of PWD (Building), Assam
4. The project must be completed within a period of 180 days from the date of issue of the Administrative approval. In no case the extension of time will be considered.
5. Deputy Commissioner, Barpeta, Assam should ensure that land is available and it is free from encumbrances and no expenditure towards cost of land will be borne by the Government.
6. Any increase in the project cost shall not be borne by the Govt.
7. Utilization Certificate and progress Report should be submitted in time for subsequent release of fund by the Govt. of Assam during the award period of TASFC by Chairman through DDOs.
8. Concerned DDO shall monitor the project and submit UC through Director, MA and then through the Urban Development Department.
