
Sub : Submission of Certificate against 2nd instalment of Basic Grant



ANNEXURE-I

CERTIFICATE ON TRANSFER OF SECOND INSTALMENT OF BASIC GRANT OF 2010-11 TO LOCAL BODIES UNDER THE AWARD OF THIRTEENTH FINANCE COMMISSION

Certified that State Government received the Second Instalment of Basic Grant of 2010-11 for Local Bodies under the award of Thirteenth Finance Commission from the Government of India on 04.08.2011. After exemption of 10 days grace period allowed due to inaccessible banking infrastructure from the date of receipt of the sanction from Government of India, the date of delay has been counted from 15.08.2011. (1) State Government transferred 2nd Instalment of General Basic Grant of 2010-11 to PRIs and ULBs for general areas on 03.09.2011 after delay of 18 days, Bodoland Territorial Council (BTC) under Sixth Schedule for PRIs and ULBs on 26.08.2011 after delay of 11 days and Karbi Anglong Autonomous Council (KAAC) & Dima Hasao Autonomous Council (DHAC) under Sixth Schedule Areas for PRIs and ULBs on 09.09.2011 and 05.09.2011 after delay of 23 days and 20 days respectively. (2) State Government transferred Special Areas Basic Grant of Second Instalment of 2010-11 for PRIs under Sixth Schedule Areas on 26.08.2011 for BTC after delay of 11 days, on 09.09.2011 for KAAC and DHAC after delay of 23 days. (3) State Government transferred Special Areas Basic Grant for ULBs under Sixth Schedule Areas on 05.09.2011 for BTC, KAAC and DHAC after delay of 20 days. A Statement to this effect is enclosed at **Annexure-II**

Further certified that an interest amount of Rs.24.87 lakh at the current RBI Bank Rate of 6% has been released to Local Bodies on 24.01.2012 for days of delay as mentioned above in transfer of 2nd instalment of Basic Grant of 2010-11 for local bodies under the award of Thirteenth Finance Commission.
