GRANT OF 2011-12 TO LOCAL BODIES UNDER THE AWARD OF THIRTEENTH  
FINANCE COMMISSION

Certified that State Government received the First Instalment of Performance Grant of 2011-12 for Local Bodies under the award of Thirteenth Finance Commission from the Government of India by mail on 18.02.2012. After exemption of **10 working days** grace period due to inaccessible banking infrastructure from the date of receipt of the sanction from Government of India, the last date of transfer of the funds to local bodies has been stipulated on 02.03.2012. 19<sup>th</sup> February (Sunday), 25<sup>th</sup> February (4<sup>th</sup> Saturday) and 26<sup>th</sup> February (Sunday) 2012 being holidays have not been counted. State Government transferred entire 1<sup>st</sup> Instalment amount of Performance Grant of 2011-12 to PRIs and ULBs within 02.03.2012. As such, no interest amount at the Bank rate is required to be paid to the local bodies under this 1<sup>st</sup> instalment of Performance Grant.
