CERTIFICATE ON TRANSFER OF FIRST INSTALMENT OF BASIC GRANT OF 2011-12 TO LOCAL BODIES UNDER THE AWARD OF THIRTEENTH FINANCE COMMISSION

Certified that State Government received the First Instalment of Basic Grant of 2011-12 for Local Bodies under the award of Thirteenth Finance Commission from the Government of India on 16.03.2012. After exemption of **10 working days** grace period due to inaccessible banking infrastructure from the date of receipt of the sanction from Government of India, the last date of transfer of the funds to local bodies has fallen on 30.03.2012. 18<sup>th</sup> March (Sunday), 24<sup>th</sup> March (4<sup>th</sup> Saturday) and 25<sup>th</sup> March (Sunday) 2012 being holidays have not been counted for the purpose of transfer of grant to local bodies. State Government transferred entire 1<sup>st</sup> Instalment amount of Basic Grant of 2011-12 to PRIs and ULBs by 23.03.2012. As such, no interest amount at the current Bank rate of RBI is required to be paid to the local bodies under this 1<sup>st</sup> instalment of Basic Grant.
